2. Financial Services Authority Regulation (POJK) Number 15 of 2023 on Know Your Client Principles Administration Services;

Consequently, the process of securing customers' and/or potential customers' approval for the retrieval of their data and/or documents will follow the available mechanisms in CORES.KSEI.
