- 9. Delivery of such a written notice is to be made by no later than 3 (three) Business Days prior to the end of the Tender Offer Period.
- 10. Having received such notification with confirmation from the appointed Securities Company, KSEI will transfer concerning ISAT shares from KSEI temporary account to account of securities company/custodian bank of respective participant by no later than 2 (two) business days following the receipt of such confirmation.

Revisions

- 9. Prior to Closing Date, participants having forwarded a Tender Offer application may cancel such a tender offer for Shares transferred into the KSEI Temporary Account entirely or partially, by conveying a written notice stating the reason thereof to **PT EDI Indonesia** with copy to KSEI & Registrar. Delivery of such a written notice is to be made by no later than 3 (three) Business Days prior to the end of the Tender Offer Period
- 10. Upon receipt of confirmation from PT EDI Indonesia stating that such written notification has been received by PT EDI Indonesia, or that the Application or Tender Offer Form has been declined due to the failure of fullfilling the provisions of Tender Offer Statement or Tender Offer Form, KSEI will transfer such shares from KSEI temporary account to the account managed by concerning securities company/custodian bank as specified in Tender Offer Form by no later than 2 (two) business days following the receipt of such confirmation by KSEI or the refusal of such application/ Tender Offer Form.
